NOW, THEREFORE, in consideration of the mutual promises made herein and of good and valuable consideration both JSPM JSCOPR and DLC hereby agree to sign a memorandum of understanding (MOU).

SCOPE OF THE MOU:

This MOU details the modalities and general conditions regarding collaboration between JSPM JSCOPR and DLC for enhancing, within the country, the availability of highly qualified manpower in the areas of TO BE INTRODUCED HERE without any prejudice to prevailing rules and regulations in JSPM JSCOPR and DLC.

The areas of cooperation can be extended through mutual consent.

SCOPE OF ACADEMIC INTERACTIONS

Both JSPM JSCOPR and DLC shall encourage interaction between the faculty members and students of both the organizations through the following arrangements:

- a) Practical training of JSPM JSCOPR students at DLC.
 - b) Industrial visit of students and faculty of JSPM JSCOPR at DLC.
 - c) Organization of seminar of DLC staff at JSPM JSCOPR.
 - d) Joint guidance of student projects/thesis in TO BE INTRODUCED HERE and other areas of interest at JSPM JSCOPR by DLC on mutually agreeable terms.
- i) The students will be allotted a Research supervisor from JSPM JSCOPR faculty members.
 - ii) The students will carry out part of their M.Pharm dissertation research work at JSPM JSCOPR and DLC depending on the nature of the work as per rules of the respective institute depending on facilities and requirements.
- vi) If the outcome of a project related to product development, process technology and design etc. which involves matter of secrecy and concern with security of the State and the Country, the same will not be allowed for publication/printing in any form such as electronically/verbal, etc. If the outcome of a project results into an intellectual property, for which rights can be secured, it will be decided on case to case basis. Similarly, sharing of expenditure in securing such rights and income accrued through royalty etc by the parties under the law will be decided on case to case basis after mutual consultation.

ARTICLE-I: SHARING OF FACILITIES

- a) JSPM JSCOPR and DLC shall make provisions to share their respective important R&D facilities in order to promote academic and research interaction in the areas of cooperation.

b) JSPM JSCOPR and DLC shall provide access to the library facilities to scientists, members of faculty and students as per the prevailing rules and norms in the respective institutes.

ARTICLE-II: CO-ORDINATION OF THE PROGRAMME INCLUDING FINANCIAL ARRANGEMENTS

a) The collaborative programme between JSPM JSCOPR and DLC shall be coordinated by a coordination committee appointed by head of both the Institutes.

b) Financial arrangements for each specific collaboration will be decided on a case-to-case basis and brought on record in each case after due approval from heads of both the Institutions.

ARTICLE-III: EFFECTIVE DATE AND DURATION OF MOU

a) This MOU shall be effective from the date of its approval by competent authorities at both ends.

b) The duration of the MOU shall be for a period of 5 years from the effective date.

c) During its tenancy, the MOU may be extended or terminated by a prior notice of not less than six months by either party. However, termination of the MOU will not in any manner affect the interests of the students/faculty/scientists who have been admitted to pursue a programme under the MOU.

d) Any clause or article of the MOU may be modified or amended by mutual agreement of DLC and JSPM JSCOPR.

ARTICLE-IV: CONFIDENTIALITY

- During the tenure of the MOU both JSPM JSCOPR and DLC will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MOU for any purpose other than in accordance with this MOU.
- Both JSPM JSCOPR and DLC shall bind their respective personnel who come into possession or knowledge of any confidential information not to disclose the same to third parties without written approval of the disclosing party or use such confidential information for any use other than intended under this agreement.
- Further both JSPM JSCOPR and DLC shall put in place adequate and reasonable measures to keep and store confidential information secure so as to prevent any unauthorized use.
